5. Custodian of the policy:

The student assessment policy shall be implemented by the principal, heads of the department and mentors

6. Policy procedure:

Assessment shall be done in one or more of the following methods.

Continuous Internal assessment:

Continuous evaluation throughout the academic year, which consists of written and practical examination, clinical test, and viva voce to assess their knowledge they acquired through the lecturer classes, and practical and clinical training, with respect to their clinical skill, professionalism and other competencies specified in the curriculum described by Indian Nursing Council and The Tamil Nadu Dr. M.G.R. Medical University.

This assessment is done at specified time interval (at least once in every two months) or at the completion of each topic. This may be in the form written examination, practical/clinical examination, or viva or combination of more than

one method.

Based on the score obtained by the students they are categorized into 3 groups,

Category	Percentage
Advanced learners	Above 70%
Average learners	50-70%
Slow learners	Below 50%

Identified slow learners are called individually for meeting with their mentor and the department head and discuss the individualized assessment report highlighting the specific areas where they are weak and improvement.

The remedial measures are suggested for the slow learners such as special coaching class, peer teaching, seminar presentation, and providing them additional learning material.

If the students have emotional and psychological factor, which impair their leaning process, assigned mentor of the specific students are requested to do special attention to these students with positive reinforcing and counseling.

If the students' performance affected because of language problem, especially students from other language medium of study in their higher secondary are trained with additional English training courses.

The students who are problem with attendance are instructed not to take unnecessary leave and to maintain minimum attendance required. The problem pertaining to their deficiency in their attendance is addressed through mentors.

Result of which shall be discussed with the students to enable them to face the university exam and perform better.

Implementation of this assessment system and the guidelines shall be communication to faculty members, students, and staff members involved in the evaluation process, during induction and orientation program.

Mid -course improvement

The students who get failed in the continuous internal examination will get additional opportunity to improve their assessment scores through the re-test. The students will be counseled by the respective mentor and remedial classes will be conducted and assignments will be given to improve the knowledge in the subject. The retest will be arranged after the remedial measures to assess the student's improvement.

7. Roles and responsibilities

Curriculum committee

The continuous internal assessment exam shall be planned and published in the academic calendar by the curriculum committee.

Exam cell

The CIA shall be conducted as per schedule by the exam cell and marks will be published in 10 days after exam.
